INDEPENDENT APPEAL PROCEDURES

Bishop Aldhelm's CE (VA) Primary School

The waiting list will be held until 31 August 2017. If you wish your child to continue on the waiting list from September 2017, you will need to write or email the Admissions Team at the above address by the end of August 2017, or to the school before the end of 2017 summer term.

If you wish to appeal against the decision not to offer your child a place you can request the appeal form and an information leaflet by emailing school.admissions@poole.gov.uk (please include "R16" in the subject field). Alternatively write to the Admissions Team at the above address. Your request should be made by the date on the reply slip. The appeal forms will be posted after that date.

St Joseph's Catholic Primary School

If you wish to appeal against the decision not to offer your child a place, your request to appeal should be made in writing and addressed to – The Chair of the Admissions Committee, c/o St Joseph's Catholic Primary School, Sancreed Road, Poole, BH12 4DZ. Your request should be made within 14 days of the date of the notification letter (by the date on the reply slip).

St Mary's Catholic Primary School

If you wish to appeal against the decision not to offer your child a place, your request to appeal should be made in writing and addressed to – The Chair of the Admissions Committee (Admission Appeals), St Mary's Catholic Primary School, Devon Road, Poole, BH15 3QQ. Your request should be made within 14 days of the date of the notification letter (by the date on the reply slip).

Merley First School

The waiting list will be held by Borough of Poole until 31 August 2016. Please contact Dorset County Council on the number below to find out how to apply for the waiting list from September 2016. If you wish to appeal against the decision not to offer your child a place, your request to appeal should be made online under the admissions appeal section on www.dorsetforyou.com/schooladmissions . If you are unable to access the internet please call 01305 221060. Your appeal should be lodged within 20 school days of the date of the notification letter.

All other schools in Poole (Academy, Community, Foundation and Voluntary Controlled)

If you wish to appeal against the decision not to offer your child a place, you can request the appeal form and an information leaflet by emailing school.admissions@poole.gov.uk (please include "R16" in the subject field). Alternatively write to the Admissions Team at the above address. Your request should be made by the date on the reply slip. The appeal forms will be posted after that date.

Schools not within the Borough of Poole

If your child has been refused a place at any school not within the Borough of Poole, you will need to contact the Local Authority where the school is sited for information about how to add your child's name to the waiting list.

If you wish to appeal against the decision not to offer your child a place, you will need to contact the relevant Local Authority for information on how to obtain an appeal form.
